OFFICIAL CONTEST RULES & REGULATIONS

"Spin to Win Wednesday"

"**Spin to Win Wednesday**" (the "**Contest**") is sponsored by North Central Co-operative Association (the "**Sponsor**"). The Contest begins 10:00 am MST every Wednesday (the "**Contest Start Date**") and ends 10:00 pm MST every Wednesday (the "**Contest Closing Date**"), known as the "**Contest Period**".

1. HOW TO PLAY

To spin to win a discount, a customer must bring their purchases to the till, then spin the wheel.

2. ELIGIBILITY:

Eligible

To be eligible to spin the wheel, a person must be the age of majority in the jurisdiction in which he or she resides as of the Contest Start Date.

Not Eligible

Any person under the age of 18.

3. PRIZE:

- **Instant Discounts Ranging from 10 – 25% off order.**

Prizes must be accepted as awarded. Prizes may not be sold, converted to cash, are non-transferable, and no substitutions are permitted. One prize per spin. Discounts will be awarded to customers on the spot.
