# **OFFICIAL CONTEST RULES & REGULATIONS**

"Spin to Win Wednesday"

"Spin to Win Wednesday" (the "Contest") is sponsored by North Central Co-operative Association (the "Sponsor"). The Contest begins 10:00 am MST every Wednesday (the "Contest Start Date") and ends 10:00 pm MST every Wednesday (the "Contest Closing Date"), known as the "Contest Period".

#### 1. HOW TO PLAY

To spin to win a discount, a customer must bring their purchases to the till, then spin the wheel.

#### 2. ELIGIBILITY:

#### Eligible

To be eligible to spin the wheel, a person must be the age of majority in the jurisdiction in which he or she resides as of the Contest Start Date.

### Not Eligible

Any person under the age of 18.

#### 3. PRIZE:
